Be it family, science, mathematics, politics, faith, sunrises, sunsets we challenge artists to reflect upon and share what is most relative to their personal universe.

Jury Information & Dates:

1. **ELECTRONIC ENTRY/**

ENTRY FEE: All entries will be done electronically. **Entry fee, \$35 for up to 2 entries.** Payment shall be made via Paypal to **Experience FiberArt, Inc.** Entry fee is non-refundable.

2. **SALES:**

If the artist chooses to have their piece for sale, the artist will receive 80% of the retail price, in US dollars, established by the artist. Liability for all taxes associated with income from the sale of artwork or from an award is the sole responsibility of the artist. In the instance of sale, the artist must provide The Art Quilt Experience with appropriate personal information for 1099 tax reporting. **The sale of juried work is optional.**

3. **AWARDS/PRIZE MONEY:**

Awards and \$300.00 prize money will be announced and distributed at the Opening Reception.

4. **DEADLINE:**

Payment, entry form and digital images must be sent electronically by **June 1, 2018.** Electronic Submission only. Please visit www.experiencefiberart.com

5. **ENTRY IMAGES:**

Entries will be accepted in digital format only. Images must be of completed work. Each work will require a set of two (2) digital images. One image must show the overall work, including the edges. The second image must show a detailed area of the work.

6. **DIGITAL IMAGE SPECS:**

File type: JPG. The "JPG" file must be formatted to be PC compatible with an extension ".JPG". JPEG files generated on a Mac (Apple) computer must be formatted to be PC compatible. Minimum acceptable resolution is 300 dpi. Image should be sized no larger than 15 inches, on the longest side. Maximum file size is 5 MB. Compression: .JPG high. Color Mode: RGB File naming: Artist's Last Name_Title of Work_height x width (in inches) for the full image file. Artist's Last Name_Title of Work_detail for the detail image file. All image will be uploaded to a Dropbox account specified during the online order entry process.

7. **ACCEPTANCE**

NOTIFICATION: Notification of acceptance will be emailed to applicant by **July 15, 2018.**

Submission Content and Hanging Requirements:

- MATERIALS:** All artwork work must original. It must be predominately fiber although the integration of non-fiber items is welcomed. Artwork derived from kits, workshops, classes or commercial patterns are **not** eligible. 2-D works must have a 4" hanging sleeve or other hardware for hanging. 3D objected must include structural components to support the artwork in a free standing position.
- DIMENSIONS:** 2-D artwork - Maximum Length 65", Maximum Width 55"
3-D artwork - Maximum height 36", width and depth 14".
- LABELING:** Each entry must have a label firmly attached to the lower side of the back. This label should include the artwork title, artist' name, address and phone number. All packaging materials must also be labeled.
- COLLABORATIVE WORKS:** Are permissible and encouraged. Please name all participants, with one being the primary artist, on entry form.

Instructions For Accepted Quilts

- DELIVERY DATE:** Accepted quilts must be delivered, in person or by mail, to Experience FiberArt, Inc. by **September 1, 2018**.

Please Note: Entries that do not have the same aesthetic and construction qualities as their photo images will be rejected by the curators.

- PACKAGING/ SHIPPING:** The artist is responsible for all costs relating to shipping and insurance of work while in transit to and from The Wilder Building. Work should be shipped in a substantial, reusable container. Experience Fiber Art will not be responsible for damage due to incorrect packing or an insufficient container. All work will be handled with care and returned in the original packing material.
- INSURANCE:** The artist is responsible for providing documentation concerning the value of the work. Artists are required to carry their own insurance.
- FIBER ART BY RETURN MAIL:** For all US entries, entrant must provide a prepaid UPS or FedEx return mailing label (tracked/signature required). This requirement also applies to international entries unless these services are unavailable or cost prohibitive as compared to regular post. International entrants sending via regular post will be invoiced, via Paypal, for return shipping. Fiber art will be shipped when payment is received. Fiber art will be shipped no later than **November 30, 2018**.
